

THE CORPORATION OF THE CITY OF COURTENAY

BYLAW NO. 2548

**A bylaw to provide for the payment of Annual Remuneration
to the Mayor and Councillors of the Corporation of the City of Courtenay**

WHEREAS it is desirable that annual remuneration be paid to the Mayor and Councillors of the Corporation of the City of Courtenay;

NOW THEREFORE the Council of the Corporation of the City of Courtenay in open meeting assembled enacts as follows:

1. This bylaw may be cited for all purposes as **“Council Remuneration Bylaw No. 2548, 2008”**.
2. That commencing January 1, 2008 there shall be paid in twelve monthly instalments out of the annual revenue of the City of Courtenay, annual remuneration as follows:
 - (a) to the Mayor an annual payment in the amount of \$39,990.00;
 - (b) to each Councillor an annual payment in the amount of \$16,398.00, representing 41% of the Mayor’s annual remuneration.
3. That commencing January 1, 2009, there shall be paid in twelve monthly instalments out of the annual revenue of the City of Courtenay, annual remuneration as follows:
 - (a) to the Mayor an annual payment in the amount of \$44,794.00;
 - (b) to each Councillor an annual payment in the amount of \$19,261.00, representing 43% of the Mayor’s annual remuneration.
4. That one-third of the annual remuneration paid to the Mayor and Councillors shall be considered as an allowance for expenses incidental to the discharge of the duties of office.
5. That for the calendar year 2010, and for each subsequent calendar year thereafter, the annual remuneration for Mayor and Councillors will be increased by a percentage amount equal to the percentage wage increase received by the City’s unionized employees.
6. That “Council Remuneration Bylaw No. 2311, 2003” be repealed.
