WHEREAS Division 12 of Part 3 of the *Community Charter* (the "*Charter*") authorizes Council for the City of Courtenay ("Council") to impose a Remedial Action Requirement on the owner or owners of a building or other structure including a requirement to remove or demolish a building, or bring it up to a standard specified by bylaw, or otherwise deal with it in accordance with the directions of Council where Council declares the building a nuisance;

AND WHEREAS Just N' Tyme Greenhouse and Hydroponic Supply Ltd. Inc. No. BC0643944 is the registered owner (the "Owner") of P.I.D. 005-007-151, Lot 2, Section 69, Comox District Plan 11365 located at 1094 McKenzie Avenue, Courtenay (the "Property");

AND WHEREAS as the property contains a commercial building (the "Building");

AND WHEREAS the building was severely damaged by fire on September 27th, 2011;

AND WHEREAS the building remains partially collapsed, heavily fire damaged and unsightly;

NOW THEREFORE Council in open meeting assembled resolves as follows:

- 1. That Council hereby considers that the commercial building on the property a nuisance within the meaning of section 74 (1) (a) of the *Charter*;
- 2. That Council hereby requires pursuant to its remedial action powers under Part 3, Division 12 of the *Charter* that the Owners:
 - a) Demolish and remove the building and contents in their entirety located on the property by June 30, 2012; and
 - b) Remediate the entire excavated site with clean fill material, level the entire site and plant it with a variety of perennial plant material.
- 3. That the City advise the Owners that they may request that Council reconsider the Remedial Action Requirement by providing the City written notice within fourteen (14) days of the date on which notice under section 77 of the *Charter* was sent and that if any or all of the actions required by the Remedial Action Requirement is not completed by the date specified for compliance, the City may take action in accordance with section 17 of the *Charter* and undertake any or all of the actions required by the Remedial Action Requirement without further notice to and at the expense of the Owners.
