1. Bob Wells, Startup Comox Valley

Bob Wells gave a presentation on Startup Comox Valley, a new grassroots network of entrepreneurs. Startup Comox Valley is one of 25 Startup communities across Canada. Their mission is to advocate for the business community and provide them the necessary tools to succeed. They encourage initiatives that provide access to financing, skills, coaching, mentoring and celebrating success.

2. Sharon Karsten and John Powell, Comox Valley Art Gallery

Sharon Karsten and John Powell provided an update on the Comox Valley Art Gallery (CVAG), including the importance of their location and connection to Courtenay's downtown core, and their efforts to make the gallery an active public space. They advised that the CVAG develops exhibitions that engage the community, bringing diverse groups and stakeholders into contact with the gallery. The gift shop generates more than \$200,000 in gross revenue annually, with over \$100,000 supporting the businesses of local artists. They invited Council and City staff to attend the "Where is here" cultural mapping symposium from July 20 to 22, 2016.

MISA CONFERENCE UPDATE Neil Borecky, the City of Courtenay's GIS Coordinator, informed Council of the upcoming Municipal Information Systems Association (MISA) of BC Conference, happening September 19 to 22, 2016 in the City of Courtenay.
