

FOOD TRUCK APPLICATION GUIDE & FAQs

If you're a food truck owner or operator wishing to operate in the City of Courtenay, this guide will assist you with the application process for a Mobile Food Vending Business Licence.

Liability Insurance	 Provide a copy of your liability insurance with the following minimum requirements: Inclusive limit of \$2,000,000 and Public Liability & Property Damage; Cross Liability Clause City of Courtenay named as joint insured under the policy Provide that the coverage under the policy cannot be cancelled or any provisions changed or deleted unless thirty days' prior written notice is given to the City by the insurer. 	
6. Discharge Management Plan	Describe how you will dispose of any fats, oils, or greases created by the business.	
7. Photographs	Photos of all sides of the food truck must be provided.	
8. Letter of permission from property	If your food truck will be located on private property, you must

How do I reserve a park location?

Food trucks interested in operating at City of Courtenay parks must first obtain a Mobile Food Vending Licence for use in City parks. Food truck park bookings are coordinated through the City of Courtenay.

A Food Truck Schedule Calendar will be maintained at <u>www.courtenay.ca/foodtrucks</u>

Please email <u>foodtruck@courtenay.ca</u> and provide the following information:

- 1. Name of Food Truck or Trailer
- 2. Requested park location(s)
- 3. Date(s) requested for each location

Staff will review your request; if there are no scheduling issues, we will send you an approval email and update the scheduling calendar accordingly.

Scheduling can be done up to two months in advance, and will be booked on a first-come, first-served basis. Vendors can choose to book any number of days at a time within the 2 month availability period. As a courtesy to other vendors, please cancel any park bookings you are not able to use.

Opening dates for scheduling are at 8:30 am on the first regular business day in each month as follows:

*Requests that are received before 8:30 am on the opening date will not be accepted.

Vendors must wait to receive approval from staff before moving food trucks to park locations. **Please note**: staff can only approve park location requests during the business week, Monday to Friday, not including statutory holidays. It may take up to 3 business days to receive an approval email.

Private Property

Licenced food trucks are permitted to operate on private property that is zoned for restaurant use, with permission from the property owner. Food trucks must be at least 30 metres away from existing brick-and-mortar restaurants. See page 8 for zoning map.



Hours of operation

Food trucks in City parks may operate during regular park operating hours, and cannot be left in place overnight.

Food trucks on private property may operate between 7:00 am and 10:00 pm.

Do I required a Mobile Food Vending Licence if I only operate at special events?

No. Food trucks that only operate at special events in the City of Courtenay are not required to obtain a Mobile Food Vending business licence. Vendors at special events fall under the Special Events Licence for each event.

Are services or utilities provided in City of Courtenay parks?

No. At this time there are no services available, and food trucks must be self-sufficient with their own water and power sources. Power generators must not create a disturbance to the surrounding area.

What about garbage and recycling?

You are responsible for keeping the area around your food truck clean and tidy. You must provide adequate waste and recycling receptacles, clean up a 10 metre radius around your food truck, and remove all collected garbage and recycling from the location once service is complete. Please help keep our city clean.

Where may I post signage?

Please place any sign boards against your food truck to avoid obstructions for pedestrians or vehicles.
