    - o Florence Filberg Centre, 411 Anderton Ave
    - Applications made on general voting day must be received by the Chief Election
      Officer by 6 p.m. on October 15, 2022
- 2. If your application is complete and you qualify to vote by mail ballot, a mail ballot package will be sent to you as soon as the ballots are available (estimated date September 26). If your name is not on the voters list, the City will send a voter registration form along with the ballot.
- 3. **If we receive your application after October 5**, there may not be enough time for you to receive the ballot by mail. After October 5, we recommend that you arrange to pick up a mail ballot package from Courtenay City Hall during business hours.
- 4. If you require your mail ballot application to be sent by courier (at your expense), please note this on your application form.
- 5. Mail ballots are also available on general voting day (for example, if you are unable to travel to/enter the voting place). Applications must be received by the Chief Election Officer by 6 p.m. on general voting day at a polling place (see instructions above).
- 6. You are responsible for ensuring that your completed ballot is received by the chief election officer on October 15, 2022 before the close of voting at 8 p.m.
