Section I - Miscellaneous Fees

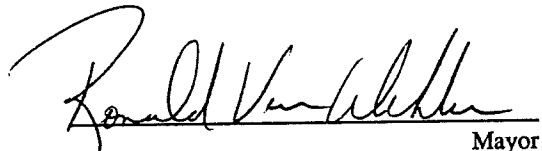
2. This bylaw comes into effect upon final adoption hereof.

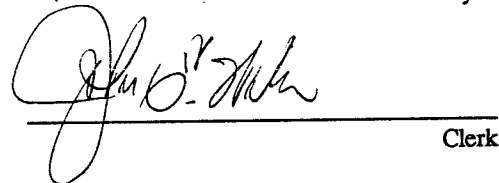
