Section I - Miscellaneous Fees

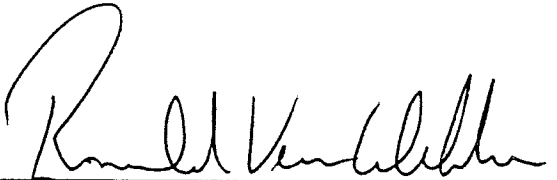
2. This bylaw shall come into force and effect on the first day of April, 1997.

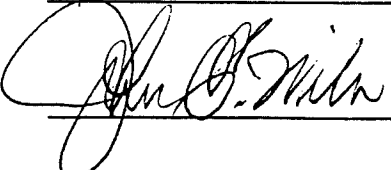
